1. The Chairman, Ministry Procurement Committee (MPC) of Ministry of Highways on behalf of the Road Development Authority (RDA), now invites sealed bids from eligible and qualified bidders for the works described below:-

The scope of work consists of Cleaning surfaces of metal structures, Removal of all kinds of metal oxides and other extraneous material deposited on metal surface, Priming and Painting as per the specification, sealing the upper embankment cavities with low pressure cement grouting to avoid water seeping through holes in the metal structure, maintain the completed surfaces, free of visual corrosion for four years and remedying defects during that period and one year beyond the maintenance period.

The above Work shall be carried out in following fifty-two (52) structures which were erected between Kurundugahahethekma Interchange (CH 67km) and Godagama Interchange (CH 124km) on Southern expressway (E-01);

2. Bidding will be conducted through the National Competitive Bidding Procedure.
3. To be eligible for contract award, the successful bidder shall not have been blacklisted and shall be currently registered with the Construction Industry Development Authority formerly named as Institute for Construction Training and Development (ICTAD) for **Bridges Specialty in C4 and above or EM 1** grade.
4. Standard Bidding Document used is: **Standard Bidding Document - Procurement of Works for Major Contracts, Second Edition January 2007 - CIDA/SBD/02 Published by Construction Industry Development Authority (Successor to ICTAD)**

5. Qualifications requirements to qualify for contract award include:
- a. Average of the annual volume of construction work performed in the last five years shall be **LKR 222 million or more**.
 - b. Experience in the construction of at least one contract of nature of this Contract and complexity equivalent to the works over the **last 10 years shall be LKR 110 million or more**.
 - c. Two Engineers with similar experience with five years and four Technical officers with five years' experience and attending similar works during last Ten years shall be the requirement of the key technical personnel at site.
 - d. Minimum Liquid Assets available shall be **LKR 37 million or more**.
6. 7. The Pre-Bid meeting will be held at **10:00 hrs on 7th January 2021** at the office of the Director, Expressway Operation, Maintenance & Management Division, Road Development Authority, Kahatagahena, Walgama, Bandaragama, and a site visit will be arranged immediately thereafter.
8. A complete set of Bidding Documents in English language shall be purchased by interested bidders on submission of a written application with the registration certificate issued by Registrar of Public contracts under the Act No. 3 of 1987, Department of Registrar Companies for Contracts, from the **Director (Procurement), Road Development Authority, 4th Floor, "Maganeguma Mahamadura", Denzil Kobbakaduwa Mawatha, Battaramulla** from **16th December 2020** until **18th January 2021** during 09:00 hrs to 15:00 hrs upon payment of a non-refundable fee of **LKR 35,000.00** (Inclusive of VAT). The method of payment will be in cash.
9. **Each** Bid shall be accompanied by a Bid- Security obtained from a reputed bank acceptable to the Employer for an amount given in Bid Data Sheet and shall be valid until **15th June 2021**.
10. Bid shall be delivered in **duplicate** to the **Chairman, Ministry Procurement Committee, Ministry of Highways, 8th Floor, Maganeguma Mahamedura, Denzil Kobbekaduwa Mawatha, Battaramulla** on or before **14:00 hrs on 19th January 2020**. **Late bids will be rejected**. Bids will be opened soon after the closing in the presence of the bidder's representatives who chooses to attend.
