A complete set of Bidding Document in English language shall be purchased by interested bidders on submission of a written application with a **Pay Order of Rs. 13,500.00 (with VAT) (valid for 91 Days) for non - refundable tender** fee drawn in favour of the "Director General -Road Development Authority" to the Director (Construction), RDA, 3rd Floor, "Maganeguma Mahamedura", Denzil Kobbekaduwa Mawatha, Battaramulla from **26.01.2021** until **15.02.2021** during **09:00 hrs to 15:00 hrs** for the each contract. As per the Public Contract Act no. 3 of 1987, the Agent and successful winners of the tender shall be registered in the Department of Registrar of Companies.
