- 02. The work consists of construction of a twin cell bridge (0+410Km) and a single cell bridge (0+690km).
- 03. Bidding will be conducted through the National Competitive Bidding Procedure. Since the total cost estimate of this procurement is below Rs. 50Mn, regional preference and CIDA grade preference shall apply as stipulated in Public Finance Circular No. 04/2016(ii).
- 04. To be eligible for contract award, the successful bidder shall be currently registered with the Construction Industry Development Authority (CIDA) in C4 and C5 grade in Bridge Construction.
