

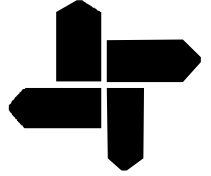

- (1) The Democratic Socialist Republic of Sri Lanka has applied for a loan from Saudi Fund for Development (SFD) towards the cost of Improvements to Bibile to Chenkaladi of PBC Road (A005). It is intended that Part of this loan will be used for eligible payments under the contracts for Construction supervision of Ampara-Uhana-Mahaoya (AUM) Road (A027) from 33+000km to 45+000km and 45+000km to 58+000km.
- (2) The Chairman, Ministry Consultancy Procurement Committee (CPCM) of Ministry of Transport & Highways, Request For Proposals (RFP) for providing the above consultancy services for the following two civil works packages for the purpose of this consultancy services. The Civil works will be administered under FIDIC Condition of Contract for Construction (RED Book First Edition -1999). It is intended to select one consultancy firm to function as Engineer in the project. More details are provided in the Terms of Reference (TOR) separately prepared for the project and included in the Request for Proposal (RFP) document.
